WAIVER AND RELEASE OF LIABILITY

1. I recognize that sailing is an activity that has an inherent risk of damage and injury associated with it. I have read Racing Rule of Sailing #4, Decision to Race, of *The Racing Rules of Sailing* and hereby acknowledge and agree that I am participating in this event entirely at my own risk.

2. I acknowledge and agree that neither Rockport Yacht Club, the Race Committee, the race sponsors, the Protest Committee, nor their respective members, officers, boards of directors, staff or representatives, will be responsible for

a. any damage to the entered boat or my other property, or

b. any injury, including death,

sustained as a result of my participation in this event, regardless of the fact that such damage may, in whole or in part, be due to the negligence of Rockport Yacht Club, the Race Committee, the race sponsors, the Protest Committee, or their respective members, officers, boards of directors, staff or representatives.

3. To the fullest extent permitted by law, I hereby WAIVE any rights I may have to sue the Race Organizers (including Rockport Yacht Club, the Race Committee, the race sponsors, the Protest Committee, and/or their respective members, officers, boards of directors, staff or representatives) with respect to personal injury or property damage suffered as a result of my participation in this event and hereby RELEASE the Race Organizers from any liability for such injury or damage to the fullest extent permitted by law whether caused in whole or in part by negligence.

4. I have taken all necessary steps to ensure that I and the entered boat are adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law or that a prudent seaman would consider advisable. I understand that my entry will not be complete until liability waivers are submitted by me and by each of my crew members. I understand that my vessel must comply with ISAF Offshore Special Regulations Category 3 and that my vessel is subject to inspection and disqualification if it does not comply with these regulations.
